

Dear Madam or Sir:

The WLALA Foundation of the Women Lawyers Association of Los Angeles is pleased to announce that it is currently accepting applications for its Fran Kandel Public Interest Grant program. Fran Kandel is WLALA's Past President (1989-1990) and recipient of the 1999 WLALA Distinguished Service Award. As a member and president of our organization, Ms. Kandel helped form the public interest grant program and helped select the early recipients of the award. Since 1985, the grant program has awarded over 30 grants to law students totaling over \$120,000.

The Fran Kandel Public Interest Grant will fund one or two projects to be completed during the summer of 2009. The Foundation will make grants to law students for projects that make governmental and social service agencies more accessible and responsible to individuals or groups whose needs are not adequately met. The maximum amount of a grant is \$5,000.

The WLALA Foundation is interested specifically in proposals that will produce some tangible materials or other "product," such as information booklets, brochures, educational curriculum, and videos. The WLALA Foundation will not consider proposals for law review articles or other purely academic research projects. Projects must benefit residents of the greater Los Angeles area. Strong preference is given to applications that have the support of a sponsoring organization, but the Grant is not intended to fund a summer clerkship or externship at an organization. It is advantageous, however, for applicants to have arranged in advance for an organization or suitable individual to supervise and guide their work on a project.

Please help the WLALA Foundation by announcing the grant program in relevant publications, and by making available the enclosed grant information packet to individuals who may be interested in applying for a grant for the summer of 2009. The application form may be photocopied. Grant applications must be received by 5:00 p.m. on Friday, March 13, 2009. ## **WLALA FOUNDATION FRAN KANDEL PUBLIC INTEREST GRANT**

The WLALA Foundation is a non-profit charitable corporation established by the Women Lawyers Association of Los Angeles ("WLALA") to increase the utility of the law as an instrument of social justice. The WLALA Foundation awards the Fran Kandel Public Interest Grant (formerly known as the WLALA Foundation Public Action Grant) to law students for projects that make governmental and social institutions and agencies more accessible and responsive to members of society whose interests are not otherwise adequately recognized or asserted. Since its incorporation in 1985, the WLALA Foundation has funded projects with a strong emphasis on public service. Through its activities, the Foundation seeks to achieve three specific goals:

- Provide help to the disadvantaged by funding projects that will directly benefit the under-represented in the greater Los Angeles area;
- Educate and expose law students to legal concerns affecting the disadvantaged in areas outside of traditional legal practices; and
- Encourage the legal community's involvement in public interest law by funding students who show the capability of and commitment to assisting those in need.

Recent representative grant projects have included:

- Compilation of a resource guide for adult children caring for elderly parents in the Los Angeles area;
- Production and distribution of an easy to understand “roadmap” to assist self-represented litigants with their divorce and child custody cases in the Los Angeles Superior Court;
- Production of a “know your rights” handbook for employment discrimination issues faced by gay, lesbian and transgender individuals;
- Creation of an educational coloring book to teach children in the dependency court who lawyers are and why they have one;
- Creation of a flyer informing expecting parents about a 2003 California law permitting parents to surrender babies within three days of birth without any negative legal ramifications to the parents;
- Production of a manual informing parents of children with medically induced learning disabilities of their rights to special educational benefits under California law;
- Creation of a pamphlet entitled: "Straight Talk to Teens in Foster Care About Mental Health Options in Los Angeles County";
- Development of a resource manual for child victims of sexual abuse;

- Preparation of materials informing AIDS-afflicted workers of their rights in the workplace;
- Production of materials to help homeless families receive Aid to Families with Dependent Children benefits to provide temporary shelter and permanent housing;
- Development of a concise Spanish-language booklet to educate Central American refugee women about their legal rights and available resources;
- Production of "know your rights" brochures in English, Spanish, and Chinese addressing the needs of, and community resources available to, immigrant and refugee battered women;
- Production of a resource guide for domestic violence survivors;
- Production of an educational brochure on the rights of disabled children and the special education resources of the California public school system;
- Development of a brochure for parents describing the dependency court process;
- Creation of a comprehensive guide to legal, mental health and community resources for homeless and runaway youth with mental health concerns.

The WLALA Foundation's Fran Kandel Public Interest Grant program enables law students to devote time to public interest projects and exposes them to legal and social concerns of disadvantaged citizens that are not ordinarily experienced in traditional law practices. The Grant program is designed not to support a summer public interest job, as worthy as one is, but rather to fund a particular project with a tangible outcome.

Discuss experiences that you believe demonstrate your commitment to the public interest; speculate about what you will learn from your project and how it ties in with your career goals. Include any other information you believe makes you and your project appropriate for a Fran Kandel Public Interest Grant from the WLALA Foundation.

Please type your essays, single-spaced, on separate sheets of paper. Put your name and the essay letter at the top of each page. We urge you to carefully proofread your essays.

#### **V. BUDGET**

Grant funds may be requested for a stipend for you (generally no more than half the total grant request), as well as for costs of your project. Previous grants have been awarded for amounts ranging from \$1,500 to \$5,000. Provide a specific breakdown of the expenses you intend to incur (i.e., printing, telephone, word processing, etc.), with a brief explanation of each cost.
